Send a reminder email without that info the day before.

Running the meeting with a high volume

Communication between meeting chairs - can restrict chat for attendees, and can write privately to each other or to all chairs.

Rebecca - Have a max of 3,000 for room. If no one is speaking, can go straight to a livestream link with no ceiling for viewers.

If we go beyond a certain threshold, we need to move to asynchronous.

Can we do things behind the registration wall on the coop website? Chair committee needs to talk to PSFC's IT about this.

Should we try the live meeting first, and then if it doesn't work move to asynchronous? Or a hybrid.

Could take written questions and vet them live.

Choice 1: asynchronous meeting: presentation/set of presentations posted in advance. can submit written questions. second meeting where we respond.

Choice 2: normal coop meeting, figure out a way for people to raise hands, use Rebecca's team. Need to do sign-ups to see the number of people - at a certain point, it's not functional.

Choice 3: use Rebecca's model along with pre-recorded content.

Materials available to members (i.e. financial report) - would be available in the hybrid version. General Meeting - would like it to be pre-recorded.
