Board candidates Richard Alvarez, Julieann Buzzanca, Avery Houser, Jimmy Royston, and Ralph Yozzo were not present at the meeting. The meeting voted using paper ballots. A team of members tabulated the paper ballot voting results and added them to the proxy votes sent in prior to the meeting.
