- Plastic reduction report. Once we receive the dispensing units the Coop will try out two alternative bags in produce and bulk aisles: a compostable bag (costs the Coop 4 cents each) and a 100% post-industrial recycled plastic bag (costs the Coop 1 cent each). The current plastic roll bags the Coop makes available cost the Coop .1 cent (one tenth of a cent) each. We will also be trying a deli container made from compostable PLA (plant-based plastic) with cream cheese. Reminder to attendees of the several alternatives to single use bags that the Coop currently sells.
- Eco-tip of the month: switch from liquid soap to bar soap. Many bar soap alternatives in aisle 5A.

# Item 2: Amendment to the Park Slope Food Coop Pension Plan and Trust (10 minutes) Proposal: To amend the Park Slope Food Coop Pension Plan and Trust as follows:

- 1. Change the pension plan year for all participants to Jan 1 Dec 31, for parity with our 401k plan:
- 2. Entry into the pension plan occurs the first day of the month after eligibility is established.
- 3. Automatic/forced lump sum and/or rollover distribution when employees leave the company with a present value less than \$5K (for parity with 401k plan). Any participant with a balance of less than \$5K must take either a lump sum or rollover their balance to a qualified retirement account regardless of when they ended their employment.
- 4. Change wording to ensure beneficiaries receive lump sum payment and/or rollovers immediately; i.e., remove any wording that restricts distribution until the normal retirement age of the beneficiary.
