Minutes of the Tuesday, June 24, 2025 Park Slope Food Coop Annual Meeting

The Annual Meeting (AM) of the Park Slope Food Coop was held at the Prospect Park Picnic House on Tuesday, June 24, 2025, beginning at 7:12 p.m. On June 12, 2025, and again on June 21, 2025, members were emailed instructions on how to vote by proxy prior to the AM. A few weeks beforehand, an announcement about the scheduled meeting and the agenda were posted on the PSFC website, foodcoop.com, inviting members to participate. Meeting materials were made available to all Coop members by email before the meeting. Chair Committee members David Moss and Maribeth Batcha served as chair and secretary.

<u>Agenda item 1 – Board of Directors Election – Two 3-year term positions open on the Board of Directors</u>

Board candidates Serko Artinian, Dan Kaminsky, Elizabeth Tobier and Brandon West addressed the meeting and answered questions. Dan Kaminsky read aloud a board candidate's statement prepared by Taylor Pate, who was not in attendance. Barbara Mazor read aloud a board candidate's statement prepared by Ralph Yozzo, who was not in attendance. Board candidate Lynn Husum was not present at the meeting. The meeting voted using paper ballots. A team of members tabulated the paper ballot voting results and added them to the proxy votes that were cast prior to the meeting. Lynn Husum and Brandon West were elected to 3-year terms on the board of directors. Below are the full election results:
